The FCC has agreed to make the following drafting amendments to the motion:

- 1 In ii) (line 27), after 'bus' insert ', tram.'
- 2 After v) (line 37), insert:
- vi) Within an Integrated Transport Strategy there remain, in some locations, opportunities for expanding the use of light rail (trams and tram trains) a form of green mass transport with less costly infrastructure than heavy rail.
- 7 In d) (line 52), after 'bus' insert ', tram'.
- 8 In 4. (line 71), after 'buses' insert ', trams'.
- 9 In 11. (Line 73), before 'the £24 billion' insert 'some of'.
- 10 In 5. (line 74), after 'Young Person's Buscard' insert 'also available for use on trams'.
- 12 In 5. (line 76), after 'bus' insert 'and tram'.
