#### **Experience**

I bring three years' experience on **Federal Council**, scrutinising Federal Board decisions, identifying successes and areas to improve. I was lead author of the Food, Poverty and Nutrition chapter for the **Food and Farming Policy Group**, have been **English Council Rep.** for the East of England since 2022, and I am currently **Chair of Liberal Voice for Women** - a grassroots group campaigning for women's rights and child safeguarding while organising crossparty briefings in Parliament. As a local campaigner in Harpenden and Berkhamsted, I understand how Board decisions affect local teams and voter perception. With Northern working-class roots, I studied Natural Sciences at Cambridge on a full grant, followed by a PhD. I am a peer-reviewed author with 20 years in healthcare and pharma including strategy development for blue-chip companies and start-ups. I have my own consultancy and work part-time for a medical charity. I am a mother, campaigner, and active community volunteer.





#### Rigour and Integrity

On every committee, I commit to reading papers in full, scrutinising evidence, and contributing constructively to improve decision-making. I am not interested in status; I am interested in changing the Party for the better. I think from first principles and reject orthodoxy. For example, the first point I raised with the President at a Federal Council meeting challenged the requirement for two Board references for committee appointments - noting this presented a barrier to the broader membership and diverse, new talent. The initial answer was 'it has always been this way' but soon after the Board agreed to remove the requirement. I will also raise issues of legal compliance to ensure our Party upholds the rule of law, strengthens its governance, and stays true to our core liberal values.

#### **Equality and Liberalism**

I believe in a changing time with deepening polarisation, it is more important than ever to stand firmly by our core liberal values: **fairness**, **freedom**, **the rule of law**, **and open**, **honest debate**. True diversity means more than representation - it requires genuine diversity of thought. I know a Board where everyone is expected to think the same is neither liberal nor effective.

#### A Record of Action

- Opened up Federal sub-committees to a wider group of members by advocating for removal of the requirement for two Federal Board references.
  - Contributed to review of legal cases and complaints system to improve our internal processes and governance.
- Secured equal treatment for Liberal Voice for Women and raised awareness of the Equality Act, ensuring conference stands and fringe event access.
- Raised issues of women's rights and child safeguarding through cross-party work in Parliament and conference fringe events, including on 'Online Harms'.

#### **Committed to More**

- Promote free speech and review restrictions within the Party, including the Code of Conduct, via feedback from members and staff.
- Support the Party to win seats through evidence-based engagement strategies.
- Advocate for accessible and trustworthy whistleblowing process so the Party can course correct in good time and improve.
- Review membership engagement and retention strategies, create new pathways for grassroots participation in our democracy and increase transparency.
