- » **Richmond Park by-election** (2016) and Ed Davey's **Kingston & Surbiton** win (2017): canvassing and leafleting to Lib Dem victories.
- » **Taking control of Hart council:** I helped the local team take and retain control of the council, proving sustained community engagement builds lasting support.

Working as a Senior Political Advisor

- » Provided staff support to **FPC Working Groups** on Policy Paper 139 (Tackling the Climate Emergency), 140 (Giving Consumers a Fair Deal), 154 (Food & Farming), 155 (Housing Crisis), & 156 (Nature Crisis).
- » **Co-authored pre-manifesto papers** and contributed to both the 2019 and 2024 election manifestos, attending FPC meetings to finalise the documents.

Policy development
