Many thanks to those who have sent in their 2022 return. Final call for the **15th March** deadline (if your accounts are over £250,000, please send us the draft version by then).

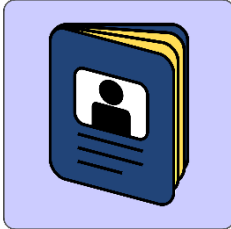
